The commercial bids of the technically successful bidders will be evaluated based on the criteria of offering the lowest rate for hiring charges.

A refundable Earnest Money through D/D of Rs. 5000/- (Five thousand) only from any Nationalized Bank in favour of "District Health & Family Welfare Samiti, Jalpaiguri Health District" payable at Jalpaiguri is to be submitted for each bid. Cooperative Society / PSU without having any proper license for business of vehicle rental will not get any exemption from deposition of Ernest Money.

The price of each tender form is Rs. 500/- and the same should be paid through Bank Cheque to the CMOH & Secretary, DH & FW Samiti, Jalpaiguri

The bidders must put both technical and financial sealed envelopes inside another big envelop. The bidder must write down on that big envelop that which car they are bidding.
