Hire Four Wheeler vehicle for R.N.T.C.P. District TB Centre, Jalpaiguri

Sealed Quotation is invited from the owners /agencies for the hiring of a four wheeler vehicles as on when required basis for the use at DTC, Jalpaiguri.

Terms & Conditions:

1. Four wheeler vehicle must be (like Tata Sumo, Bolero, & as similar with engine capacity more than 2000 c.c.), preferably NEW or not more than five years old, in good condition, on the day of acceptance of bid. The vehicle has to be placed at DTC within 15 (fifteen) days from the day of acceptance of bid with commercial number or documents supporting applied for commercial number & blue book/any proof of showing engine capacity.
2. **The four wheeler vehicle must be available as and when required basis.** The cost of normal diesel including Mobil (one liter for 500 km run) will be paid from this end on submission of monthly bill.
3. Bill will be entertained on as daily basis (approx. average 20 days per month.)
4. Rate: per day maximum Rs/-600.00 (Rupees Six Hundred only).
5. The kilometer of the vehicle must be always in proper running condition and shall indicate the distance correctly.
6. Any taxes, surcharges, road taxes insurance charges, pollution clearance etc, have to be paid by the owner and must be updated in due time. The department will be no way of responsible for this.
7. Loss, damages, worn & tear, accident of the said four wheeler vehicle, if any, will be born by the owner of the four wheeler vehicle. The department will not be responsible in this regards.
8. The successful Quotationer shall be liable for replacement for an alternative vehicle as temporary measure in case of original vehicle becomes unserviceable. No extra rate will be paid for replacement.
9. The owner should mentioned the hiring charge per day inclusive of driver's remuneration, food and lodging, maintenance and repairing and other incidental charges of the vehicle.
10. The four wheeler vehicle shall be suitable for journeys on roads (metalled or nonmetalled) in steps mountainous terrains of West Bengal as well as in plains in all weather condition.
11. Ground clearance should be sufficient enabling the vehicle can ply easily through deeply rutted and water logged roads of considerable depth.
12. The driver provided shall be experienced of driving in hill roads, properly licensed, capable long run journeys and out stationed half at a stretch. He should maintain official confidentiality and accordingly should not be changed frequently. Bio-data of the driver should be submitted to the office and approval should be obtained. The driver should possess knowledge of automobile mechanism and capable of running maintenance.
13. The rate shall be valid for 3(three) years from the date of acceptance.
14. Any party shall be able to exit the agreement any time with a notice least of one month in advance.
15. If selected bidder failed to place the vehicle in stipulated time , the next lowest bidder will be called for place the vehicle with same terms & conditions
16. *Documents needed during submission*
 - a. *Filled up proforma / Application form*
 - b. *Attested photocopy of latest Income tax clearance certificate & Photocopy of PAN Card.*
 - c. *Earnest money of **Rs.10000/-** (Rupees Ten Thousand) only by way of NSC/Bank Draft of DCR in any Nationalized Bank drawn in favour of **"District Health & Family Welfare Samiti (RNTCP), Jalpaiguri"***

d. One participant can drop only one bid.

17. The contract will be valid for one year and renewable on the basis of satisfactory performance report, on the approval of DH&FW Samiti, Jalpaiguri.

18. If multiple participants bid same ,then first year of manufactured (less old) and thereafter mileage will be considered
