**TERMS & CONDITIONS FOR SUBMISSION OF SHORT TERMS TENDER NOTICE VIDE NIT NO.
IN RESPECT OF MEDICINES FOR DRS, JALPAIGURI**

1. Tenders to be submitted in the prescribed forms only which are to be down load from website: www.wbhealth.gov.in/uri tender & www.Jalpaigurihealth.com from 16-01-2013 for X-Ray Films.
2. Annual Turnover Rs. 5 Lakh of the **previous year** including Income Tax Return Certificate must be submitted along with the bid.
3. Earnest money of Medicines Rs.25,000/-, as Demand Draft drawn in favour of C.M.O.H & Secretary, D.H. & F.W. Samiti, Jalpaiguri.
4. Self attested copy of up to date VAT, Income Tax, Professional Tax clearance certificate and valid drug license is required to be furnished with tender (whichever is applicable). Non compliance with this requirement will render the tender liable to be rejected.
5. The bidder has to submit the GMP certificate and quality assurance certificate of the medicines.
 - a. The rate should be quoted inclusive of all taxes and freight charges and items to be delivered to the CMOH, Jalpaiguri.
 - b. The rate should be quoted per unit exactly shown in the proforma as per list of items stated in the tender form. Rate to be quoted both in figures and words.
6. All the instruction embodied in the term & conditions are binding for the tenders.
7. After tender has been accepted, intimation will be communicated to the bidders by the C.M.O.H, Jalpaiguri and bidders will have to furnish security deposit @ 5% of the value of anticipated order to be placed as postal saving, pass book of fixed deposit of any schedule bank to be pledged in favour of the C.M.O.H & Secretary, D.H. & F.W. Samiti, Jalpaiguri.
 - a. In case of failure of supply according to term of contract, CMOH, Jalpaiguri will have the right and discretion to determine this contract and forfeit the security deposit and or to be free to make purchase from any course at the risk and account of such bidder beside forfeiture of the security deposit.
 - b. If Lowest bidder fails to supply then the next highest bidder will be entertained the undersigned deserve the authority to except / reject lowest bids to maintain of quality supply.
 - c. The bidders will submit samples during opening of tenders.
 - d. Testing will be done as per govt. norms.
8. Rate must be hold good throughout the financial year 2012-2013. Order for requirement will be placed with the successful bidders within that period and supplies thereof will have to made within 2 weeks of placement of order as directed by the CMOH, Jalpaiguri.
9. Medicine supply must accompany chemical analysis report.
10. Earnest Money of the bidders shall be liable to be forfeited if:
 - a. a). The bidders withdraw his tender as a whole or for any items at any stage of opening of the tenders.
