- Caste Category Certificate (if any). **In case of OBC candidates' category 'A' or 'B' must be mentioned specifically in the caste certificate.**
- Marksheets and Certificates of Graduation or Post Graduation or both.
- All the experience certificates issued and stamped by the appropriate authority starting from oldest to latest.
- Experience certificates must consist of Name of the post, Employer's Name, Employee's Name, Date of joining (DOJ) and Date of Leaving (DOL) otherwise her experience will be treated as invalid. No appointment letter will be treated as experience.
- In case of married candidates – Marriage registration certificate.
